



## Warwickshire Pride 2020 Artist Agreement

This agreement is made between **insert artist's name here** (The Artist) and Warwickshire Pride (The Host).

1. The Artist has agreed to perform a **insert length of set here** set at Warwickshire Pride on Saturday 22<sup>nd</sup> August 2020. The time slot for the performance is **insert time slot here**. The performance will take place at: The Pump Room Gardens, Parade, Leamington Spa, Warwickshire, CV32 5AA.
2. The Artist agrees to arrive for their performance no later than **insert a time half an hour before the performance time here** and agrees to report to the backstage area on arrival to inform the attending Backstage Co-ordinator that they have arrived. A Warwickshire Pride steward can assist with this.
3. The Artists agrees to bring any specialist equipment, instruments or backing tracks that are required.
4. The Host agrees to provide a stage and PA system, including speakers, microphones, CD and MP3 player, and plug-ins for instruments.
5. The Host also agrees supply The Artist with liquid refreshments free of charge in the Warwickshire Pride backstage area.
6. **Insert clause regarding performance fee here. Example 1 – The Host agrees to pay a fee of £100 to The Artist for this performance. The Host will pay the fee to The Artist upon submission of an invoice after the performance by The Artist. Example 2 – The Artist agrees that The Host will not be paying a fee to The Artist for this performance.**
7. **Insert clause regarding payment of expenses here. Example 1 – The Host agrees to cover the cost of train travel to Warwickshire Pride 2020 for The Artist. These expenses can be reimbursed upon production of travel receipts by The Artist. Example 2 – The Artist agrees that The Host will not be covering The Artist's expenses.**
8. The Artist will observe any rules laid down by The Host or owner of the land where the performance takes place as notified to The Artist, including those relating to health and safety.
9. The Artist is entitled to make use of the Warwickshire Pride backstage area at any point during the festival times of 11:00am – 6:00pm, including for preparation of their performance, relaxing, changing outfits, or anything else connected to their appearance at Warwickshire Pride. For security reasons, only The Artist and The Artist's representatives, up to a maximum of two people, will be allowed access to the backstage area. The Host will be unable to admit entry to friends, family or any entourage connected to The Artist.
10. The Artist agrees to be featured in any promotional undertakings by The Host in the lead up to Warwickshire Pride 2020 and after Warwickshire Pride 2020, including a listing on the Warwickshire Pride website, social media pages and mentions in the press that may include

photographs. The Artist agrees to provide The Host with a promotional photograph within seven days of The Host confirming the booking of The Artist.

11. The Artist has full responsibility for any items relating to their performance that they bring with them. The Host is not liable for any damage or loss of personal items relating to the performance of, or belonging to, The Artist.
12. If The Artist is unable to attend Warwickshire Pride 2020 for their performance, a minimum of 21 days' notice must be provided to The Host. If The Artist fails to provide a minimum of 21 days' notice to The Host, they will be liable to pay The Host a financial penalty of £100, plus return any fees that have been paid. In exceptional circumstances, such as illness or bereavement, the financial penalty can be waived by The Host. This will be at The Host's discretion.
13. If The Host is required to cancel Warwickshire Pride 2020, or The Artist's performance, a minimum of 24 hours' notice must be provided to The Artist. If The Host does not provide a minimum of 24 hours' notice to The Artist, then any already paid for travel expenses incurred by The Artist must be covered by The Host upon production of valid travel expense receipts. The Artist agrees that in the event of cancellation by The Host, any agreed fees will not be paid by The Host.
14. This contract shall be governed by English Law.
